<u>Time and Place Sealed Proposals Will be Opened and Considered.</u> Sealed proposals will be opened and bids tabulated October 27, 2022 in the Board Room, Conference Center, 2nd Floor, Des Moines International Airport, 5800 Fleur, Drive, Des Moines, Iowa, 50321, for consideration by the Des Moines Airport Authority Board (Board) at its meeting on November 8, 2022. The Board may award a Contract at said meeting, or at such other time and place as shall then be announced.

General Nature of Public Improvement

Passenger Terminal Site Preparation

Demolition of existing aircraft hangar (DSM Building #10), miscellaneous demolition and relocation of aircraft hangar Building #9; site preparation, new roof, overhead doors, and building automation for relocated Building #9, demolition of concrete slabs for Building #9, Building #10, and former Building #7, demolition and removal of 27,000 SY of airfield and parking lot pavement, installation of 2,250 LF of relocated perimeter security fencing, approximately 90,000 CY of embankment construction at future terminal building, 1,100 LF of relocated storm and sanitary sewer, 1,750 LF of 2-4" communication conduits, installation of 1,000 LF of 48 inch storm sewer, installation of 1,400 LF of 10 inch sanitary sewer, and relaying power to Building #8 from a new Mid-American transformer.

The Engineer's opinion of probable construction cost for the Work is \$4,800,000 to \$5,300,000.

<u>Commencement of Work.</u> Work on the improvements shall be commenced any time after a written Notice to Proceed is issued and shall be completed as stated below. The Notice to Proceed will be issued after the preconstruction conference in March 2023, Submittal and Acceptance of the Contractors Safety Plan Compliance Document, and submittal of all required insurance certifications

Bid Security and Bonds. Each Bidder shall accompany its bid with bid security as defined in Iowa Code Section 26.8, as security that the successful Bidder will enter into a Contract for the work bid upon and will furnish after the award of Contract corporate Surety Performance and Payment Bond(s), in a form acceptable to the Board, for the faithful performance of the Contract, in an amount equal to one hundred percent (100%) of the amount of the Contract. The Bidder's security shall be in the amount of five (5%) percent of the Bid and shall be in the form of a cashier's check or a certified check drawn on an FDIC insured bank in Iowa or on an FDIC insured bank chartered under the laws of the United States; or a certified share draft drawn on a credit union in Iowa or chartered under the laws of the United States; or a Bid Bond on the form provided in the Contract Documents with corporate Surety satisfactory to the Board. The bid shall contain no condition except as provided in the specifications.

<u>Performance, Payment, and Maintenance Bonds.</u> Each successful Bidder will be required to furnish corporate Surety Bonds in an amount equal to one hundred percent (100%) of its Contract price. Said Bonds shall be issued by a responsible Surety approved by the Des Moines Airport Authority and shall guarantee the faithful performance of the Contract and the terms and conditions therein contained and shall guarantee the prompt payment of all material and labor, and protect and save harmless the Des Moines Airport Authority from claims and damages of any kind caused by the operations of the Contract and shall also guarantee the maintenance of the improvement caused by failures in materials and construction for a period of one (1) year from and after acceptance of the Contract.

<u>Award of Contract.</u> All proposals submitted in accordance with the instructions presented herein will be subject to evaluation. Bids may be held by the Des Moines Airport Authority for a period not to exceed 30 days from the date of the bid opening for the purpose of conducting the bid evaluation. Prospective Bidders are hereby advised that award of contract is contingent upon the Owner receiving Federal funding assistance under the Airport Improvement Program. Awarded Bidder may be required to hold their bid open for a period of up to 120 days following letting.

The Owner will base the award of contract upon the lowest aggregate sum proposal submitted from those bidders the Owner confirms as being responsive and responsible. The right is reserved, as the Des Moines Airport Authority may require, to reject any and all bids and to waive any informality in the bids received.

Completion of Work. The project shall occur during the 2023 construction season. The Phase 1 work (installation of relocated AOA fence) has an early start date of April 3, 2023, and a late start date of April 10, 2023. Phase 1 has a duration of 20 calendar days. Phase 1A in-line drain installation has a duration of 7 calendar days, and must occur at the start of Phase 1. Phase 2 (the primary construction phase) may start immediately after Phase 1 is complete. Phase 2 has a duration of 120 calendar days, along with a completion date of August 29, 2023. Phase 2A established a date for the relocation of Building #9. Building #9 must be relocated by June 9, 2023. Phase 2B work (sanitary and storm sewer installation inside the AOA fence) must be completed concurrent with Phase 2, and has a duration of 40 calendar days. Phase 3 work (relocated AOA fence installed in Phase 1) has a start date of September 4, 2023, and a completion date of September 18, 2023 (duration of 15 calendar days). Also, relocated Building #9 (Building #44B) must be ready for occupancy by the end of Phase 3.
