Bids received after the deadline for submission of bids as stated herein shall not be considered and shall be returned to the late bidder unopened.

<u>Time and Place Sealed Proposals Will be Opened and Considered.</u> Sealed proposals will be opened and bids tabulated March 30, 2022 in the Board Room, Conference Center, 2<sup>nd</sup> Floor, Des Moines International Airport, 5800 Fleur, Drive, Des Moines, Iowa, 50321, for consideration by the Des Moines Airport Authority Board (Board) at its meeting on April 12, 2022. The Board may award a Contract at said meeting, or at such other time and place as shall then be announced.

# General Nature of Public Improvement

### **Runway Intersection Reconstruction**

Contract#: 2020-39-20

Reconstruction of the Runway 13/31 and Runway 5/23 mainline and shoulder pavement that is located within the runway safety areas of both runways. Length of reconstruction on Runway 13/31 is approximately 600 ft., which includes the 150' x 150' pavement at the intersection of both runways. Length of reconstruction on Runway 5/23 on both sides of Runway 13/31 is approximately 195 ft (total length approximately 390 ft). Due to the location of this project, construction must be complete in 34 calendar days between August 30, 2023 and October 2, 2023. 24 hour operations are allowed to complete the project within the allotted 34 calendar days. Project includes removal of existing runway pavement section, subdrain installation, grading, crushing existing airport-provided concrete to recycled concrete aggregate base, installation of aggregate base, drainable base, PCC mainline and shoulder paving, runway edge lighting, runway centerline and touchdown zone lighting, traffic control, and seeding/site restoration.

Project includes the following approximate quantities:

- 13. Cable and Conduit Installation for Airfield Lighting

The Engineer's opinion of probable construction cost for the Work is \$7,350,000 to \$7,900,000.

<u>Commencement of Work.</u> Work on the improvements shall be commenced any time after a written Notice to Proceed is issued and shall be completed as stated below. The Notice to Proceed will be issued after the preconstruction conference on July 12<sup>th</sup>, 2023, Submittal and Acceptance of the Contractors Safety Plan Compliance Document, and submittal of all required insurance certifications

Bid Security and Bonds. Each Bidder shall accompany its bid with bid security as defined in Iowa Code Section 26.8, as security that the successful Bidder will enter into a Contract for the work bid upon and will furnish after the award of Contract corporate Surety Performance and Payment Bond(s), in a form acceptable to the Board, for the faithful performance of the Contract, in an amount equal to one hundred percent (100%) of the amount of the Contract. The Bidder's security shall be in the amount of five (5%) percent of the Bid and shall be in the form of a cashier's check or a certified check drawn on an FDIC insured bank in Iowa or on an FDIC insured bank chartered under the laws of the United States; or a certified share draft drawn on a credit union in Iowa or chartered under the laws of the United States; or a Bid Bond on the form provided in the Contract Documents with corporate Surety satisfactory to the Board. The bid shall contain no condition except as provided in the specifications.

Performance, Payment, and Maintenance Bonds. Each successful Bidder will be required to furnish corporate Surety Bonds in an amount equal to one hundred percent (100%) of its Contract price. Said Bonds shall be issued by a responsible Surety approved by the Des Moines Airport Authority and shall guarantee the faithful performance of the Contract and the terms and conditions therein contained and shall guarantee the prompt payment of all material and labor, and protect and save harmless the Des Moines Airport Authority from claims and damages of any kind caused by the operations of the Contract and shall also guarantee the maintenance of the improvement caused by failures in materials and construction for a period of one (1) year from and after acceptance of the Contract.

Award of Contract. All proposals submitted in accordance with the instructions presented herein will be subject to evaluation. Bids may be held by the Des Moines Airport Authority for a period not to exceed 30 days from the date of the bid opening for the purpose of conducting the bid evaluation. Prospective Bidders are hereby advised that award of contract is contingent upon the Owner receiving Federal funding assistance under the Airport Improvement Program. Awarded Bidder may be required to hold their bid open for a period of up to 120 days following letting.

The Owner will base the award of contract upon the lowest aggregate sum proposal submitted from those bidders the Owner confirms as being responsive and responsible. The right is reserved, as the Des Moines Airport Authority may require, to reject any and all bids and to waive any informality in the bids received.

<u>Contract Documents.</u> A copy of said plans, specifications, and form of contract, and estimated total cost is now on file in the office of the Director of Engineering and Planning and may be examined at the Des Moines International Airport, 2nd Floor, Room 207, 5800 Fleur, Drive, Des Moines, Iowa.

<u>Sales Tax.</u> The bidder should not include sales tax in the bid. A sales tax exemption certificate will be available for all material purchased for incorporation in the project.

#### DAVIS BACON REQUIREMENTS: (29 CFR PART 200 APPENDIX II(D))

The Contractor is required to comply with wage and labor provisions and to pay minimum wages in accordance with the current schedule of wage rates established by the United States Department of Labor.

### DISADVANTAGED BUSINESS ENTERPRISE – 49 CFR PART 26:

The contractor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of this DOT-assisted contracts. In accordance with 49 CFR Part 26.45, the sponsor has established a contract goal of <u>5.60%</u> percent participation for small business concerns owned and controlled by certified socially and economically disadvantaged enterprise (DBE). The bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part 26, to meet this established goal.

These goals are applicable to all of the contractor's construction work (whether or not it is Federal or federally-assisted) performed in the covered area. If the contractor performs construction work in a geographical area located outside of the covered area, it shall apply the goals established for such geographical area where the work is actually performed. With regard to this second area, the contractor is also subject to the goals for both federally funded and non-federally funded construction regardless of the percentage of federal participation in funding.

Completion of Work. Construction of the intersection shall occur between 12:30 am on August 30, 2023 and 11:30 pm on October 2, 2023. These dates are non-negotiable. The accelerated 34 calendar day construction period is necessary due to the location of the project. DSM will be operating on a shortened Runway 5/23 during the intersection reconstruction. Should the Contractor fail to fully complete the work within this 34 calendar day construction period, liquidated damages of Sixteen Thousand, One Hundred Dollars (\$16,100.00) will be assessed per each 24-hour period that the construction remains incomplete after 11:30 pm on October 2nd, 2023.

Should the Contractor succeed in fully completing the work in less than thirty-four (34) calendar days, an enhancement of payment in the amount of One Hundred Ten Thousand Dollars (\$110,000.00) for each 24-hour period that construction is completed prior to 11:30 pm on October 2nd, 2023, up to a maximum amount of Five Hundred Fifty Thousand Dollars (\$550,000), will be issued to the Contractor.

The 'Intersection Preconstruction Phase' shall be completed no later than July 31, 2023. Items included in the preconstruction phase include having construction materials on-site, crushing the owner provided uncrushed concrete to P-219 recycled concrete aggregate gradation, and completing the control strips for the P-307 cement treated drainable and the P-501 PCC concrete
