

**NOTICE TO BIDDERS

RECONSTRUCT RUNWAY 5/23, PHASE 2  
AT DES MOINES INTERNATIONAL AIRPORT**

Time and Place for Filing Sealed Proposals. Sealed bids for the work comprising each improvement as stated below must be on file before 11:00 a.m. on April 30, 2020 in the office of the Executive Director, Des Moines International Airport, 2<sup>nd</sup> Floor, Room 207, 5800 Fleur, Drive, Des Moines, Iowa, 50321. Bids received after the deadline for submission of bids as stated herein shall not be considered and shall be returned to the late bidder unopened.

Time and Place Sealed Proposals Will be Opened and Considered. Sealed proposals will be opened and bids tabulated 11:00 a.m. on April 30, 2020 in the Board Room, Conference Center, 2<sup>nd</sup> Floor, Des Moines International Airport, 5800 Fleur, Drive, Des Moines, Iowa, 50321, for consideration by the Des Moines Airport Authority Board (Board) at its meeting on May 11, 2021. The Board may award a Contract at said meeting, or at such other time and place as shall then be announced.

General Nature of Public Improvement

**Reconstruct Runway 5/23, Phase 2**

Contract#: 2020-02-20

Reconstruction of 1,825 LF of Runway 5/23 pavement, between Taxiway D and the Runway 23 end, and reconstruction of approximately 2,900 LF of taxiways that are parallel to and crossing Runway 5/23 within the limits of construction on Runway 5/23. Bid alternate for the project is PCC paving of a 15 ft wide Runway 23 perimeter road (2,175 LF in length). Major construction items includes removal of existing runway pavement section, storm sewer installation, grading, aggregate base, drainable concrete base, PCC paving, PCC mill and HMA overlay, airfield lighting and signage, traffic control, and seeding/site restoration.

Project includes the following approximate quantities:

1. 122,700 SY of Pavement Removal
2. 3,300 LF 24 to 42 Inch Storm Sewer
3. 210,000 Cubic Feet of Stormwater Underground Detention
4. 13,700 LF Subdrain
5. 117,00 SY of Recycled Aggregate Base
7. 109,000 SY Airfield PCC Pavement
8. 4,000 SY Perimeter Road PCC Pavement (Bid Alternate)
9. 21,000 CY Unclassified Excavation

10. 3,800 TONS of HMA
11. 105,000 LF of Compression Joint Sealant
12. 58 Acres Seed and Mulching
13. LED Runway and Taxiway Edge, and Taxiway Centerline Light Fixture Installation
14. Cable and Conduit Installation for Airfield Lighting and Airport Communications

The Engineer's opinion of probable construction cost for the Work is \$22,500,000 to \$23,500,000.

Commencement of Work. Work on the improvements shall be commenced any time after a written Notice to Proceed is issued and shall be completed as stated below. The Notice to Proceed will be issued after the preconstruction conference, Submittal and Acceptance of the Contractors Safety Plan Compliance Document, and submittal of all required insurance certifications

Bid Security and Bonds. Each Bidder shall accompany its bid with bid security as defined in Iowa Code Section 26.8, as security that the successful Bidder will enter into a Contract for the work bid upon and will furnish after the award of Contract corporate Surety Performance and Payment Bond(s), in a form acceptable to the Board, for the faithful performance of the Contract, in an amount equal to one hundred percent (100%) of the amount of the Contract. The Bidder's security shall be in the amount of five (5%) percent of the Bid and shall be in the form of a cashier's check or a certified check drawn on an FDIC insured bank in Iowa or on an FDIC insured bank chartered under the laws of the United States; or a certified share draft drawn on a credit union in Iowa or chartered under the laws of the United States; or a Bid Bond on the form provided in the Contract Documents with corporate Surety satisfactory to the Board. The bid shall contain no condition except as provided in the specifications.

Performance, Payment, and Maintenance Bonds. Each successful Bidder will be required to furnish corporate Surety Bonds in an amount equal to one hundred percent (100%) of its Contract price. Said Bonds shall be issued by a responsible Surety approved by the Des Moines Airport Authority and shall guarantee the faithful performance of the Contract and the terms and conditions therein contained and shall guarantee the prompt payment of all material and labor, and protect and save harmless the Des Moines Airport Authority from claims and damages of any kind caused by the operations of the Contract and shall also guarantee the maintenance of the improvement caused by failures in materials and construction for a period of one (1) year from and after acceptance of the Contract.

Award of Contract. All proposals submitted in accordance with the instructions presented herein will be subject to evaluation. Bids may be held by the Des Moines Airport Authority for a period not to exceed 30 days from the date of the bid opening for the purpose of conducting the bid evaluation. Prospective Bidders are hereby advised that award of contract is contingent upon the Owner receiving Federal funding assistance under the Airport Improvement Program. Awarded Bidder may be required to hold their bid open for a period of up to 90 days following letting.

The Owner will base the award of contract upon the lowest aggregate sum proposal submitted from those bidders the Owner confirms as being responsive and responsible. The right is reserved, as the Des Moines Airport Authority may require, to reject any and all bids and to waive any

informality in the bids received.

Contract Documents. A copy of said plans, specifications, and form of contract, and estimated total cost is now on file in the office of the Director of Engineering and Planning and may be examined at the Des Moines International Airport, 2nd Floor, Room 207, 5800 Fleur, Drive, Des Moines, Iowa.

Copies of the Bidding & Contract Documents may be obtained at Beeline and Blue, 2507 Ingersoll Avenue, Des Moines, IA 50312 (515-244-1611 or [www.beelineandblue.com](http://www.beelineandblue.com)), in accordance with the Instructions to Bidders. A record of plan holders will be updated daily and posted on Beeline and Blue's Online Plan room. Documents are available at a cost of fifty dollars (\$50.00), which is refundable, provided the following conditions are met: (1) The Contract Documents are returned complete and in a reusable condition, and (2) they are returned within fourteen (14) calendar days after the award of the project.

Sales Tax. The bidder should not include sales tax in the bid. A sales tax exemption certificate will be available for all material purchased for incorporation in the project.

Federal Provisions: This project is subject to the following Federal provisions, statutes and regulations:

DAVIS BACON REQUIREMENTS: (29 CFR PART 200 APPENDIX II(D))

The Contractor is required to comply with wage and labor provisions and to pay minimum wages in accordance with the current schedule of wage rates established by the United States Department of Labor.

DISADVANTAGED BUSINESS ENTERPRISE – 49 CFR PART 26:

The contractor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of this DOT-assisted contracts. In accordance with 49 CFR Part 26.45, the sponsor has established a contract goal of **5.60%** percent participation for small business concerns owned and controlled by certified socially and economically disadvantaged enterprise (DBE). The bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part 26, to meet this established goal.

TITLE VI SOLICITATION NOTICE

The Des Moines Airport Authority, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

AFFIRMATIVE ACTION REQUIREMENT

1. The Offeror's or Bidder's attention is called to the "Equal Opportunity Clause" and the "Standard Federal Equal Employment Opportunity Construction Contract Specifications" set forth herein.

2. The goals and timetables for minority and female participation, expressed in percentage terms for the contractor's aggregate workforce in each trade on all construction work in the covered area, are as follows:

Timetables

Goals for minority participation for each trade	<u>4.5%</u>
Goals for female participation in each trade	<u>6.9%</u>

These goals are applicable to all of the contractor's construction work (whether or not it is Federal or federally-assisted) performed in the covered area. If the contractor performs construction work in a geographical area located outside of the covered area, it shall apply the goals established for such geographical area where the work is actually performed. With regard to this second area, the contractor is also subject to the goals for both federally funded and non-federally funded construction regardless of the percentage of federal participation in funding.

The contractor's compliance with the Executive Order and the regulations in 41 CFR Part 60-4 shall be based on its implementation of the Equal Opportunity Clause, specific affirmative action obligations required by the specifications set forth in 41 CFR 60-4.3(a), and its efforts to meet the goals. The hours of minority and female employment and training shall be substantially uniform throughout the length of the contract, and in each trade, and the contractor shall make a good faith effort to employ minorities and women evenly on each of its projects. The transfer of minority or female employees or trainees from contractor to contractor or from project to project, for the sole purpose of meeting the contractor's goals, shall be a violation of the contract, the Executive Order, and the regulations in 41 CFR Part 60-4. Compliance with the goals will be measured against the total work hours performed.

3. The contractor shall provide written notification to the Director, Office of Federal Contract Compliance Programs (OFCCP), within 10 working days of award of any construction subcontract in excess of \$10,000 at any tier for construction work under the contract resulting from this solicitation. The notification shall list the name, address, and telephone number of the subcontractor; employer identification number of the subcontractor; estimated dollar amount of the subcontract; estimated starting and completion dates of subcontract; and the geographical area in which the subcontract is to be performed.

4. As used in this notice and in the contract resulting from this solicitation, the "covered area" is Polk County, Iowa.

BUY AMERICAN CERTIFICATION – 49 USC PART 50101:

The contractor agrees to comply with 49 USC Part 50101, which provides that Federal funds may not be obligated unless all steel and manufactured goods used in AIP-funded projects are produced in the United States, unless FAA has issued a waiver for the product; the product is listed as an Excepted Article, material Or Supply in Federal Acquisition Regulation subpart 25.108; or is included in the FAA Nationwide Buy American Waivers Issued list.

As a condition of bid responsiveness, Bidders must complete and submit as part of their proposal the enclosed Buy American certification. Bidder must indicate whether it intends to meet Buy America preferences by only installing steel and manufactured products produced with the United State of America; or if it intends to seek a permissible waiver to the Buy America requirements.

Completion of Work. The project shall occur during the 2021 and 2022 construction seasons. The 2021 Phase 1 work (construction of the temporary taxiway) has an early start date of August 23, 2021, and a completion date of October 15, 2021. Phase 1 work also has a duration of 35 Calendar days. 2022 Phase 2A (Taxiway P Construction) and Phase 2B (Runway 5/23, Taxiway

R, Taxiway B, Taxiway R1/P1, and perimeter road construction) work has an early start date of March 21, 2022. Phase 2A work must be completed prior to the start of Phase 3 work. Phase 3 work (construction of Taxiway G connector at the Terminal Apron) must be completed in 30 calendar days, and has a completion date of November 10, 2022. Phase 2B also has a completion date of October 26, 2022. There are minor sub-phases of work within the project that have defined durations.
